# BIOGRAPHY

In 2013, Steven Alan Metcalf II, Esq. founded the Metcalf Law Firm, PLLC, in the Wall Street area. In 2017, Mr. Metcalf joined forces with his partner Nanette Ida Metcalf forming Metcalf & Metcalf, P.C.
